Manager's Report for September 15, 2020

a. C.C.V.C.J.P.A. Investments and Dental & Vision Insurance

The District's current investment balance is \$222,379.76

b. Safety Meeting

c. 2020 Green Pool Flyover & Inspection Warrant

The District has served 2 warrant inspections for unresponsive green pool properties. The District has worked with local law enforcement agencies and animal control to achieve a safe encounter with residents subject to the warrant inspection.

d. Saint Louis Encephalitis Virus Update

Madera County is reporting a fatality from St. Louis Encephalitis Virus (SLEV) in a male in his 90s from August 2020. This is the first confirmed case of SLEV in the state of California in 2020 and the first case in Madera County since 1976. While preliminary testing originally suggested the West Nile Virus, further testing has now confirmed SLEV as the final diagnosis.

e. West Nile Virus Updates Week of September 4th

Humans

• A total of 10 human cases of West Nile virus (WNV) illness were reported this week from 5 counties: Contra Costa (2), Los Angeles (4), Merced (1), Riverside (1), and Stanislaus (2). These are the first human WNV cases reported from Contra Costa County this year. In 2020, a total of 45 human WNV cases have been reported from 11 counties. Of the 45 cases, 33 (73%) had neuroinvasive illness and two (4.4%) were fatal. The median age of the individuals was 61 years and 32 (71%) were male. Dates of symptom onset ranged from June 16 to August 19. In addition to the 45 cases, 5 asymptomatic WNV infections have been reported from Los Angeles (2), Merced (1), and Stanislaus (2) counties. At this time last year, 62 human WNV cases had been reported from 13 counties.

Dead Birds

 A total of 29 WNV positive dead birds were reported this week from 5 counties: Fresno (1), Los Angeles (2), Orange (6), Sacramento (12), and Yolo (8). In 2020, a total of 171 WNV positive dead birds have been reported from 17 counties. At this time last year, 103 WNV positive dead birds had been reported from 16 counties.

Mosquito Pools

West Nile virus

A total of 297 WNV positive mosquito pools were reported this week from 19 counties: Butte (4), Contra Costa (1), Fresno (42), Kern (15), Kings (16), Los Angeles (9), Madera (22), Orange (36), Placer (3), Riverside (2), Sacramento (12), San Bernardino (8), San Joaquin (48), Shasta (8), Solano (2), Stanislaus (33), Sutter (1), Tulare (27), and Yolo (8). In 2020, a total of 1,717 WNV positive mosquito pools have been reported from 26 counties. At this time last year, 2,815 WNV positive mosquito pools had been reported from 24 counties.

St. Louis encephalitis virus

A total of 32 St. Louis encephalitis virus (SLEV) positive mosquito pools were reported this week from 7 counties: Fresno (15), Imperial (1), Kern (3), Kings (1), Madera (3), Riverside (8), and Tulare (1). In 2020, a total of 300 SLEV positive mosquito pools have been reported from Fresno (116), Imperial (10), Kern (15), Kings (6), Madera (5), Riverside (139), San Joaquin (1) and Tulare (8) counties. At this time last year, 224 SLEV positive mosquito pools had been reported from 9 counties.
