

Humans

West Nile virus

No Human cases in Madera County in 2024.

St. Louis encephalitis virus

No human cases of St. Louis encephalitis virus (SLEV) disease have been reported. At this time last year, 3 human cases of SLEV disease had been reported from 2 counties.

Dead Birds

In 2024, 488 WNV positive dead birds have been reported from 21 counties. At this time last year, 743 WNV positive dead birds had been reported from 30 counties.

Mosquito Pools

West Nile virus

In 2024, 1,904 WNV positive mosquito pools have been reported from 25 counties. At this time last year, 4,223 WNV positive mosquito pools had been reported from 31 counties.

St. Louis encephalitis virus

At this time last year, 639 SLEV positive mosquito pools had been reported from 15 counties.
