West Nile

Humans

West Nile virus No new human cases of West Nile virus (WNV) disease were reported this week. In 2025, 1 human case of WNV disease has been reported from 1 county. At this time last year, no human cases of WNV disease were reported.

Dengue virus

No locally acquired dengue infections have been reported in 2025. Travel associated dengue cases are indicated in the CDPH Weekly Update on Number of Dengue Infections:

Dead Birds

A total of 7 new WNV positive dead birds were reported this week from 4 counties: Fresno (3), Kern (1), San Joaquin (2), and Tulare (1). These are the first WNV positive dead birds from Fresno, Kern, and San Joaquin Counties this year. In 2025, a total of 26 WNV positive dead birds have been reported from 7 counties. At this time last year, 84 WNV positive dead birds were reported from 10 counties.

Mosquito Pools

West Nile virus

A total of 104 new WNV positive mosquito pools were reported from 11 counties: Fresno (9), Kern (5), Kings (1), Madera (4), Merced (1), Placer (16), San Diego (16), San Joaquin (3), Stanislaus (3), Tulare (45), and Yolo (1). These are the first detections of WNV activity in Kings and Madera counties and the first detection of WNV positive mosquito pools in San Diego County this year. In 2025, a total of 397 WNV positive mosquito pools have been reported from 15 counties. At this time last year, 269 WNV positive mosquito pools were reported from 17 counties.

St. Louis encephalitis virus

A single new St. Louis encephalitis virus (SLEV) positive mosquito pool was reported this week from 1 county: Fresno (1). This is the first detection of SLEV activity in Fresno County this year. In 2025, 2 SLEV positive mosquito pools have been reported from 2 counties: Fresno (1) and Riverside (1). At this time last year, 10 SLEV positive mosquito pools were reported from 3 counties. Sentinel Chickens No seroconversions have been reported in 2025.
